2) Declarations of Interest

Chairman Richard King: declared no financial or business interest in any matters on this agenda nor in any land put forward for development in the Neighbourhood Plan or any land excluded from development in the Neighbourhood Plan process.

Cllr Tim Oliver: a relation of his owns Gale Field which is proposed for development in the Neighbourhood Plan.

Cllr Pat Parr: neighbour to site proposed for the Older People's Accommodation at Orchard Nurseries.

Clir Lois Tilden: declared no financial or business interest in any matters on this agenda nor in any land put forward for development in the Neighbourhood Plan or any land excluded from development in the Neighbourhood Plan process.

3) Minutes of the Previous Meeting

The minutes of the meeting on 7th December 2021

The minutes were approved and signed as a true record of proceedings.

Proposed: Cllr Lois Tilden. **Seconded:** Cllr Tim Oliver. **All agreed. Abstained**: Peter Rawlinson and Jeff Hopkins. Neither was present at the 7^{th of} December meeting.

4) Matters Arising from 7th December 2021

a) Sale of the Shop

No update to report.

b) Post Office

Service levels remained inconsistent during December.

c) Heathlands Garden Settlement

The EPC submission to Maidstone Borough Council's (MBC) Regulation 19 Submission Local Plan Consultation objecting to the inclusion of the proposed Lenham Heathlands Garden Community Development was made both via letter and the on-line portal. MBC acknowledged the submission. Egerton Parish Council's submission was copied to Borough Councillor Ken Mullholland for distribution at Ashford Borough Council.

d) South-East Water replacement mains water works

Egerton Parish Council noted that South-East Water's work to replace the water main on Pluckley Road re-started on 4 January but that the appropriate signage was not back in place as agreed with SE Water and Clancy Docwra before the start of the works.



Action: Vice Chairman Peter Rawlinson to follow up on the missing signage with both parties. Clerk to alert EPC Highways representative John Lawton.

A letter from Kent County Council to County Councillor Charlie Simkins was acknowledged. The letter showed that KCC Highways team was very aware of the disruption and traffic issues that the water mains replacement works at Pluckley were having in Egerton and allied areas as well as causing damage to verge and road surfaces.

e) Village website

The Clerk advised that a meeting had been set for January 27th to review the village website.

6) Neighbourhood Plan

Egerton Neighbourhood Plan Steering Group (ENPSG) chair Jane Carr confirmed that the revised Referendum version of The Egerton Neighbourhood Plan was circulated to all councillors prior to the meeting and welcomed councillors' thoughts and comment ahead of the vote to approve the final Referendum document.

She advised that the biggest change made in the new Referendum Version was that a site had not been specified for the development of local needs affordable housing.

Villagers will be able to read the Referendum Version on the Egerton Neighbourhood Plan website as well as in hard copy, and could raise any concerns or questions they might have at open meetings organised for:

Voting for the Referendum, organised by Ashford Borough Council, will be held on Thursday February 10th between the hours of 7am-10pm at the Egerton Games Barn.

Cllr Claire Foinette advised that it was important for people to note that the Neighbourhood Plan was the villagers' own plan and not a plan produced by Egerton Parish Council.

Jane Carr confirmed that a single sheet leaflet would be delivered to all houses in Egerton to urge residents to vote in favour of the plan and that advertising boards would also be placed around the village with key details and dates.

EPC view: The application creates a wider extension on the rear of this semi-detached property than currently exists and will leave a narrow gap between the boundary with its neighbour. The design and materials conform to the principles in the Parish Design Statement.

Recommendation: comment only.

Chairman Richard King advised that the noticeboard on the wall outside of the village shop was in a poor state of repair.

Action: Vice Chairman Peter Rawlinson to investigate and provide estimates for its repair.

Cllr Lois Tilden advised that a new site would be required for the noticeboard on the wall of the former Queen's Arms pub as work on the pub to transform it into housing units had commenced.

Action: Cllr Lois Tilden to check suitability of a wide grass verge nearby and if not already registered with the land registry to investigate scope for EPC registering and using it.

14) Any other business

• Solar panelling

Installation of solar panelling on the Games Barn roof was proposed by EPC councillor and member of the Games Barn sub-committee Claire Foinette. She advised that installation at the same time as a new roof would save some thousands on additional scaffolding, would meet the Games Barn's current and future energy requirements, and be a sustainable step for the village to take. She advised that the panels would sit on the western roofline overlooking the main car park and that an application had been made to the Geoff Wickens Trust for a grant to help towards the cost of the installation. Cllr Foinette said competitive estimates for the work had been sought and that the Games Barn Committee was seeking the approval of Egerton Parish Council to install panelling and delegate all further decisions about the choice of contractor to the Games Barn Committee.

Proposed: Cllr Claire Foinette. Seconded: Chairman Richard King. All in agreement.

Action: The Clerk to distribute a letter to residents living near to the Games Barn to advise of the work to the Games Barn roof as well as critical dates and allied details.

Further works to improve the Games Barn facility will be discussed more widely at a later date.

Bus stop line marking

Cllr Lois Tilden advised that the white lines that identified the bus stop on the highway outside of the former Queen's Arms pub had worn away.

Action: Cllr John Lawton to follow up with KCC to ensure the white lines are redefined.



EPC January meeting date

Cllr Lois Tilden suggested that the January meeting date should be moved to the second Tuesday of January to allow enough time for work to be undertaken by the Clerk in preparation for the meeting during the extended public holiday period.

The council agreed that it would be appropriate and agreed to meet on the 2nd Tuesday of January in 2023.

The outstanding issues below are listed with the KCC Reference, the date reported, the footpath number, the location, the difficulty experienced and the status of action.

- 1. **PROW 210554009.** 24/05/21. AW76 opposite Kingsland Lane, Mundy Bois Road. Broken stile. Status: Still Awaiting Allocation
- 2. **PROW 210561834.** 24/05/21. AW79 Mundy Bois Road to Rockhill Road (opposite The Laurels). Broken stile (bottom plank flicks up when you step on it as both ends have come loose from the supporting posts). Status: Still Awaiting Allocation.
- 3. **PROW 210834144.** 15/08/21. AW90 Green Wickets Animal Sanctuary, Rockhill Road end. A resident reported that the wooden fingerpost is lying on the ground at the entrance of the property. The Clerk lives nearby and will check that it has been re-erected. Status: Work Scheduled.
- 4. **PROW 210959063.** 10/09/21. AW75 at Heronsdale, Wanden Lane. Egerton resident complaint of overgrowth (brambles) and fence panel leaning towards the footpath. Status: Still Awaiting Allocation.
- 5. **PROW210998966.** 20/09/21. AW76 opposite Kingsland Lane, Mundy Bois Road, broken stile. This was reported in July 2019 under ref PROW214250. In March 2020 KCC reported 'landowner action' and deleted it from their records. Status: Still Awaiting Allocation.



- 6. **PROW211126930.** 09/11/21. Part of AW87 to the west of the church behind the Glebeland houses where the path is quite narrow. Badgers have again been active and collapsed the side of the path about halfway along. Don and I temporarily blocked either end off, reported it and within 2 days KCC had come out and put an official block on it and posted notices around and about. Michael Ellis visited me to return the fencing stakes we had temporarily used and said that contractors will attend and assess what remedial action to take. Status: Still Work Scheduled.
- 7. **PROW211117086.** 21/11/21. AW64 Footpath opposite Egerton House on Greensand Way in a small, wooded area towards the byway up to Coach Road. Two planks missing/broken on the bridge over a small stream. 2 photos shown on next page. Status: Work Scheduled.
